Objective

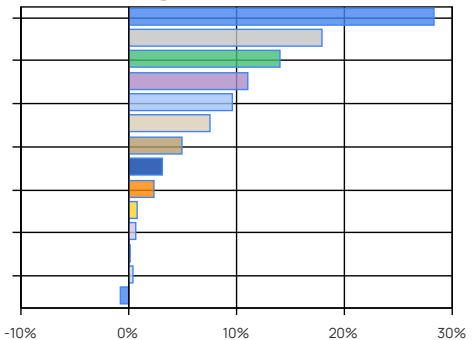
