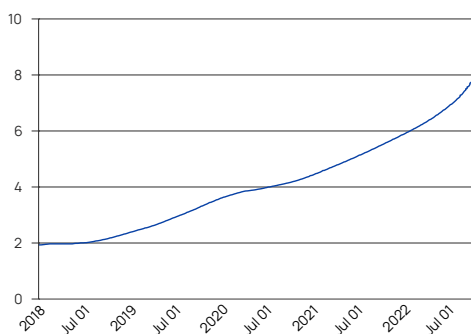

Objective

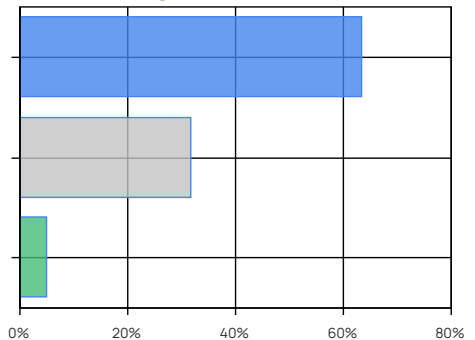

It is a liquidity parking fund that invests in surety bonds, demand deposits and time deposits in the main Argentinean banks. The fund has daily liquidity (redemption payment on the day, T+0).
