Objective

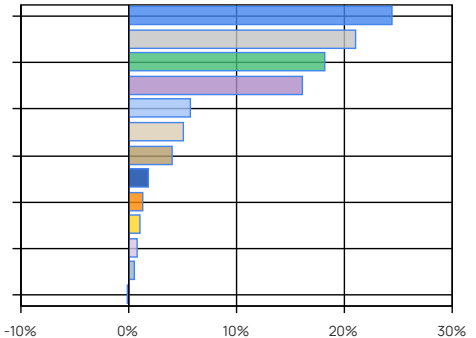
