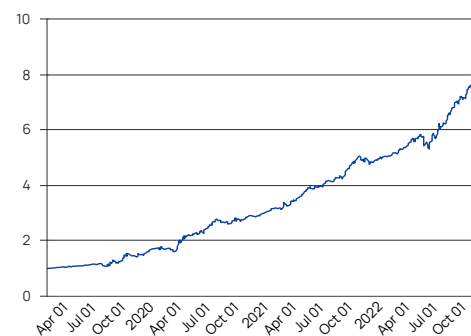

### Objective

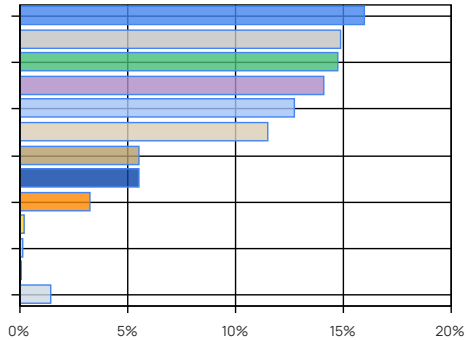
