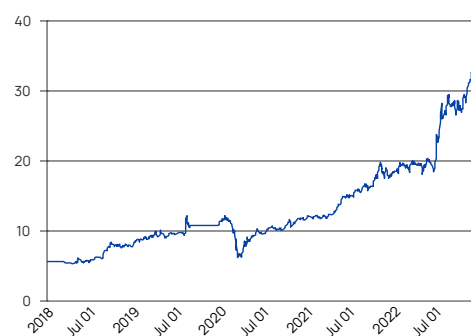

### Objective

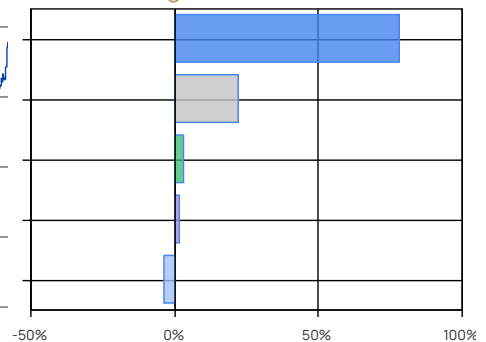
