Objective

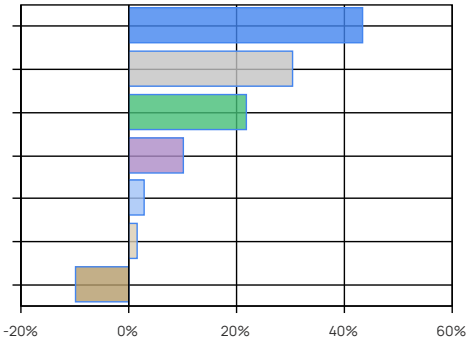
