### Objective

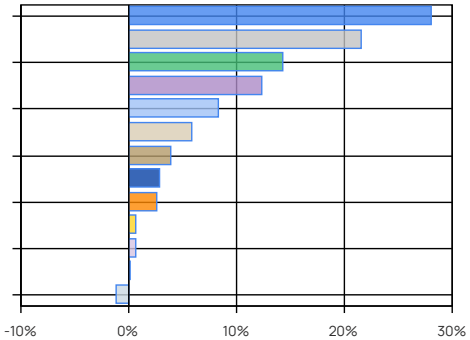
