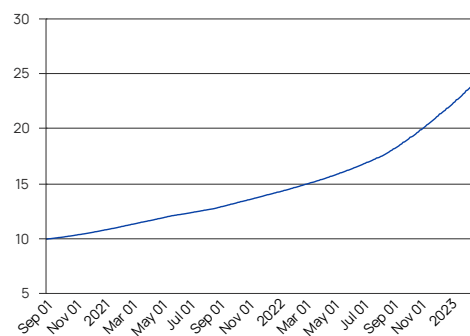

## Objective

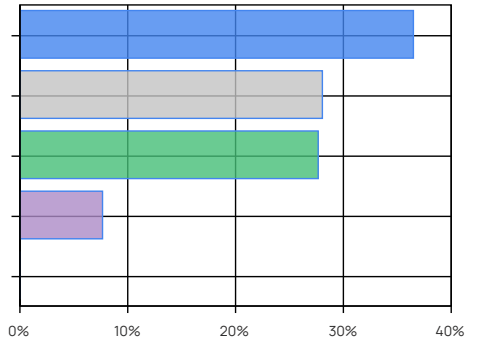
