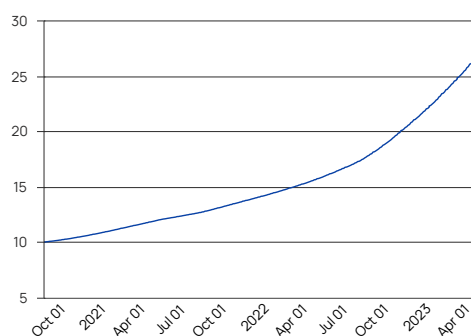

## Objective

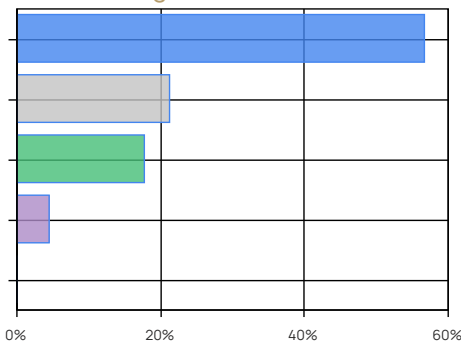
