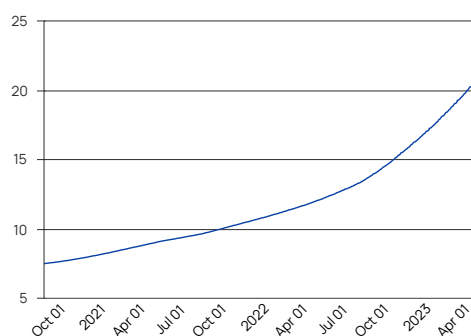

Objective

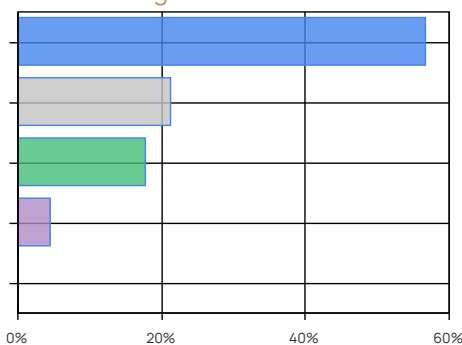
