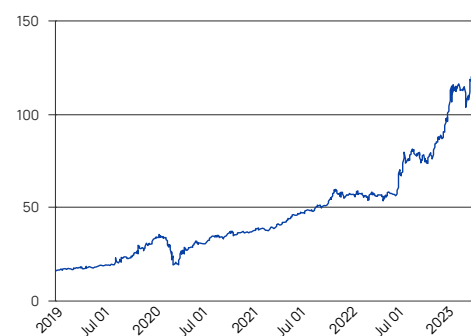

## Objective

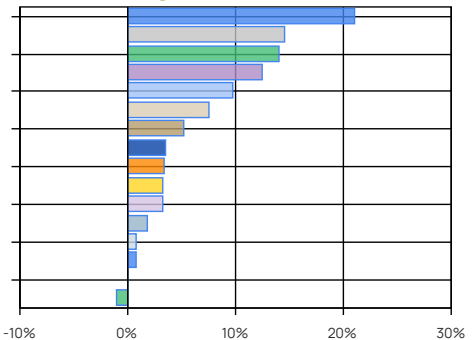
