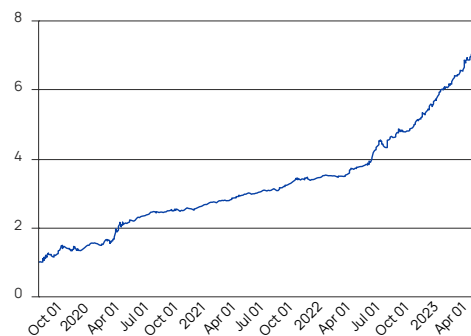

Objective

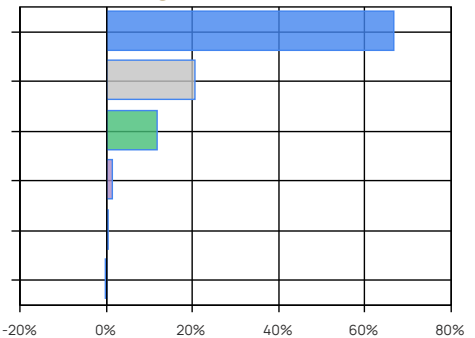
Delta Gestión IX es un fondo de renta fija que busca ofrecer un desempeño comparable a la evolución del tipo de cambio del dólar oficial (Comunicación "A" 3500 BCRA) en el mediano plazo. Para tal fin, Delta Gestión IX invierte al menos un 75% en activos de renta fija argentina dólar-linked con sesgo a corporativos y/o instrumentos de renta fija en pesos con cobertura de futuros de dólar en Rofex; pudiendo invertir el 25% restante en bonos corporativos argentinos en dólares dentro de los de mejor calidad crediticia. La duration target del fondo es de 1,5 años. Pago de rescate en 2 días hábiles.
