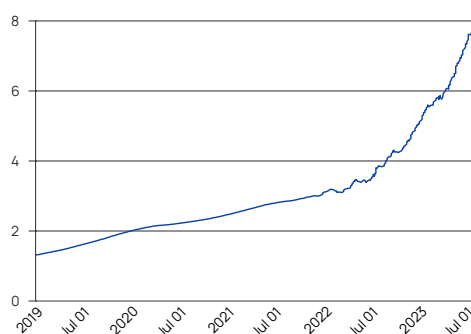

Objective

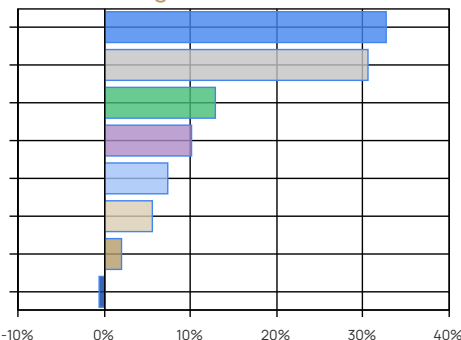
