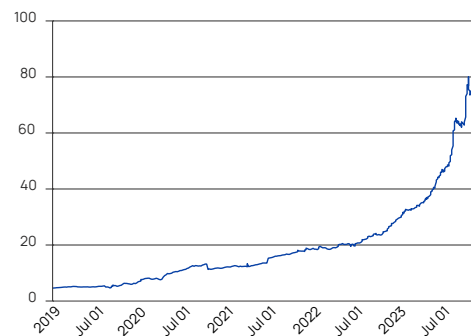

Objective

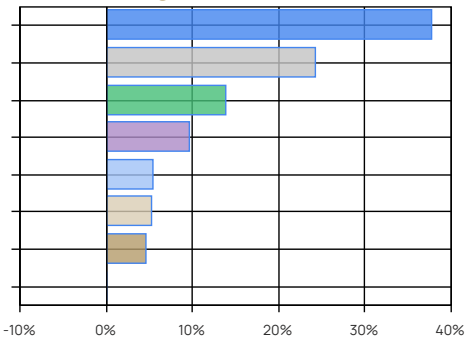
