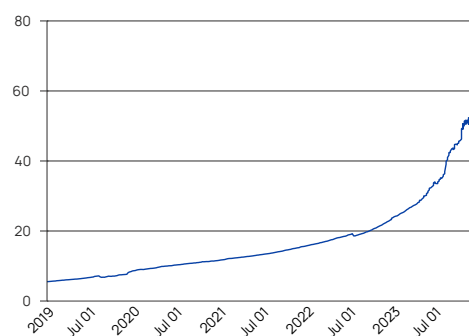

## Objective

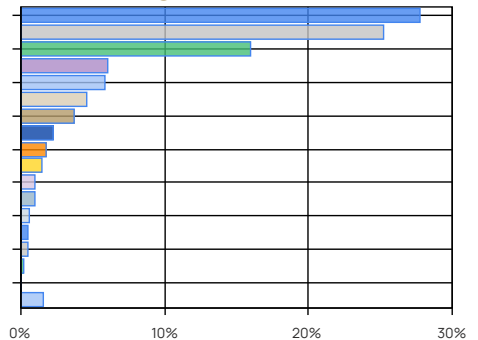
