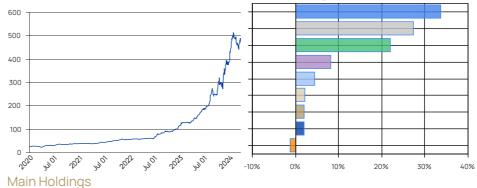
Objective
