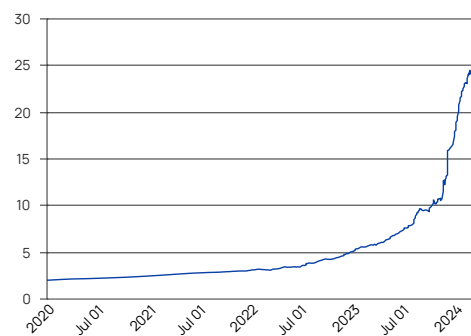

Objective

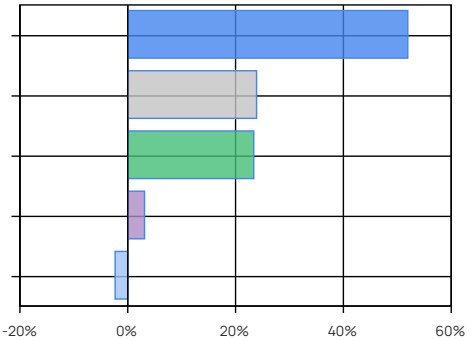
