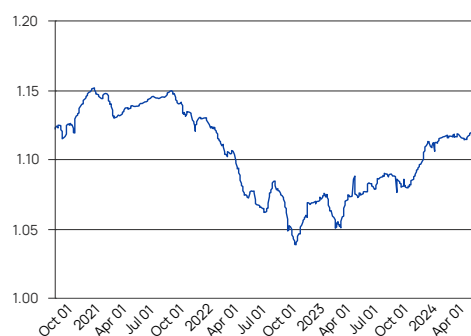
Objective

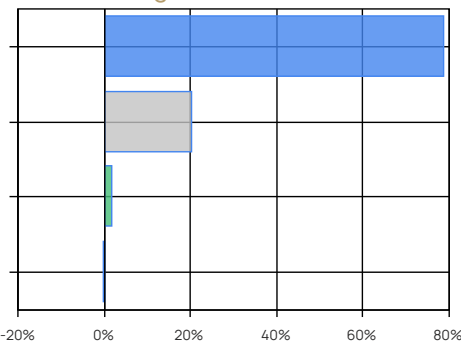
