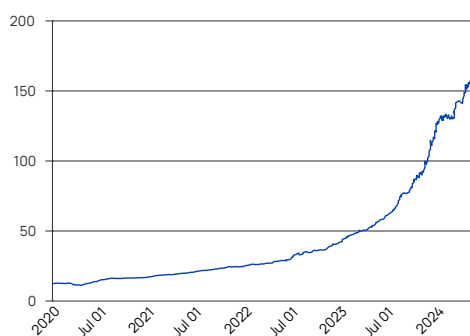
Objective

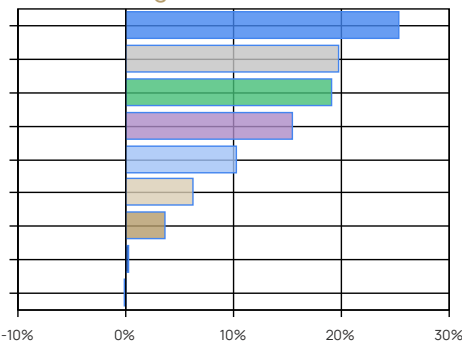
