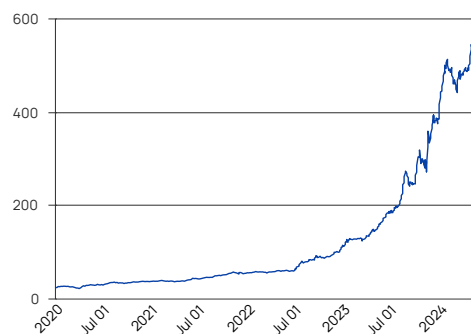

### Objective

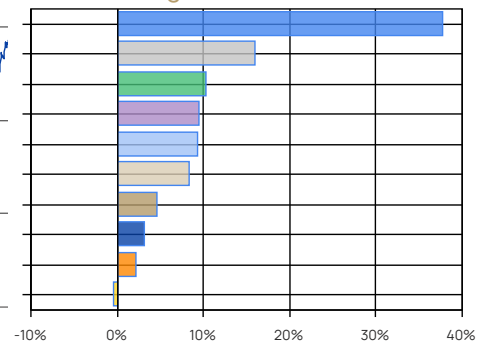
