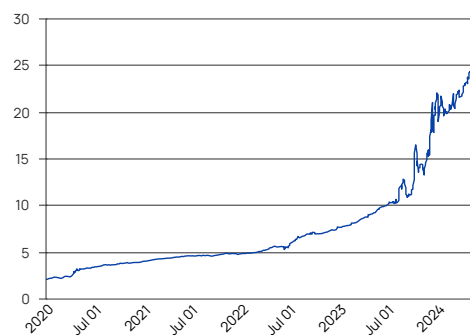

### Objective

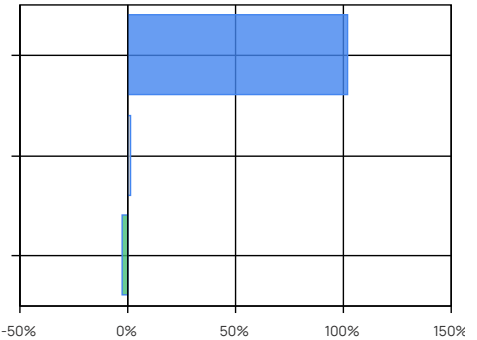
