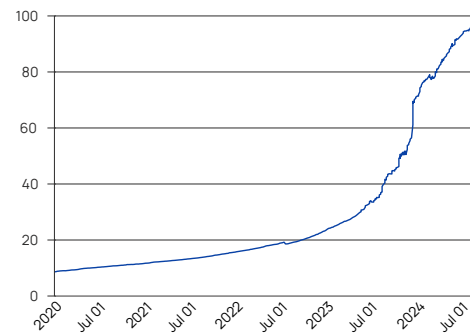

## Objective

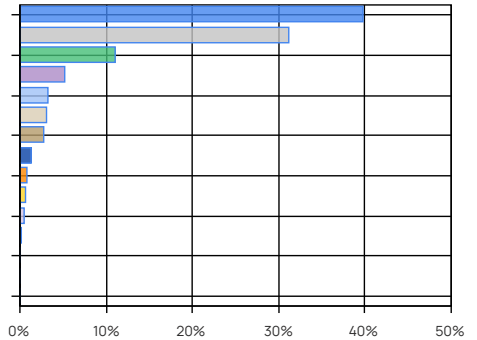
