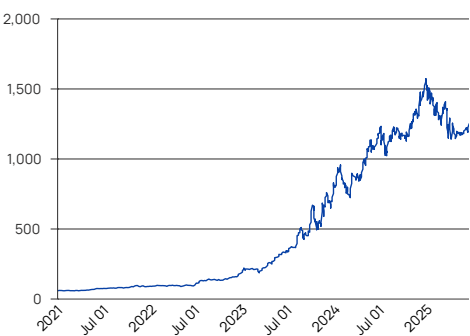

Objective

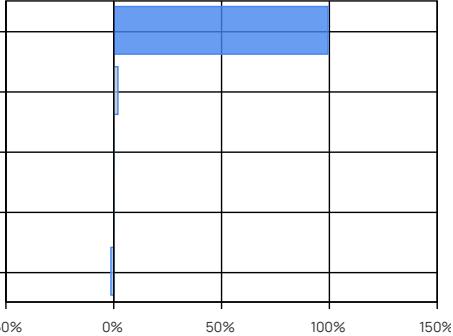
