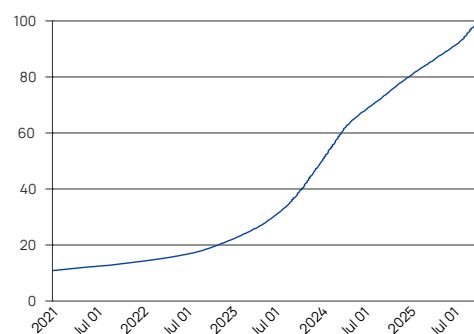

Objective

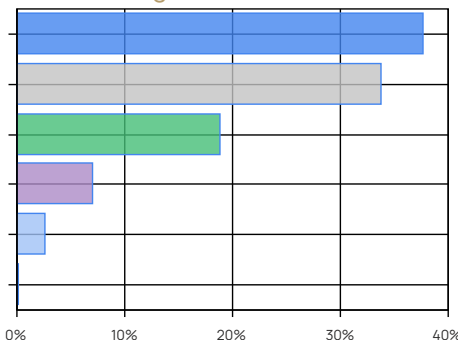
Cohen Pesos aims to maximize short-term cash balances while maintaining strict credit risk control and daily liquidity management. The Fund may invest up to 35% in accrual instruments (time deposits in leading Argentine banks and repurchase agreements), with the remainder allocated to instruments with immediate liquidity (interest-bearing bank accounts, pre-cancellable time deposits, etc.). The benchmark index is 75% of the Badlar rate.
