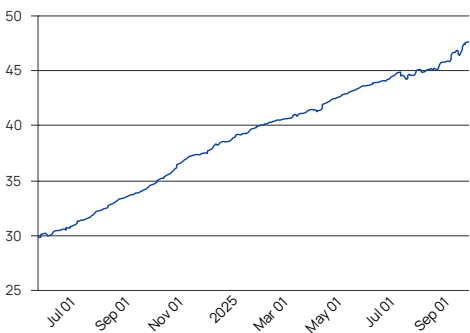

Objective

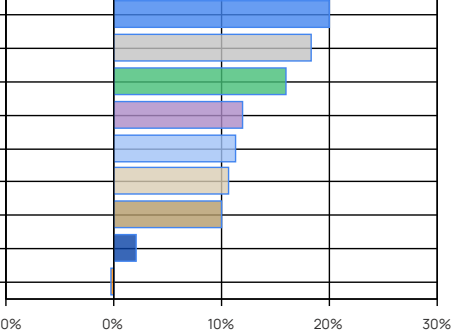
Delta Performance is a fixed income ARS sovereign short-term fund that optimizes a portfolio composed mainly of instruments issued by the Argentine Treasury with a target duration of 3 months. In a 30-day horizon it seeks to achieve returns that are higher than those of money market funds and the Badlar rate.
